SECRETARY'S REPORT: The minutes for the November meeting were approved as presented.

TREASURER'S REPORT: Our current ATOM account balance at the end of November was \$6,723.17. Throughout the month we had \$960 in deposits which included: clinic registrations and membership fees. Expenses included: newsletter printing totaling \$460.80. Membership for 25-26 is currently at 92. 24-25 was 140. At the time of the meeting, we had 49 registered for the 2026 clinic. We had 75 attendees at the 2025 clinic.
